

Membership Terms and Conditions Aligned Leisure Pty Ltd As Trustee for Aligned Leisure Trust

The following Membership Terms and Conditions (Conditions) apply to membership of Casey Leisure.

THIS IS AN IMPORTANT DOCUMENT AND YOU SHOULD READ IT CAREFULLY BEFORE AGREEING TO THE FOLLOWING TERMS AND CONDITIONS. UPON AGREEING TO THE TERMS AND CONDITIONS CONTAINED IN THIS DOCUMENT, YOU ACKNOWLEDGE THAT YOU HAVE READ AND UNDERSTAND THESE TERMS AND CONDITIONS

You apply, either yourself or on behalf of a Member under the age of 18 as their parent/guardian, for membership of Casey Leisure. In consideration of the application being accepted, you (or you and the Member) acknowledge and agree to the terms and conditions below. You agree to these terms and conditions on your own behalf, or where relevant also on behalf of the Member.

1. DEFINITIONS AND INTERPRETATION

(a) In these Conditions the following expressions have the following meanings:

Casey Leisure means Aligned Leisure Pty Ltd As Trustee for Aligned Leisure Trust trading as Casey Leisure (ABN 38 602 127 519).

Claim means and includes any action, suit, proceeding, claim, demand, damage, penalty, cost or expense however arising from or in connection with any Member Activities, but does not include a claim against Casey Leisure by any person expressly entitled to make a claim under a Casey Leisure insurance policy.

Member means an applicant for membership of Casey Leisure as indicated in a membership application.

Member Activities mean performing or participating in any capacity in any authorised or recognised Casey Leisure activity.

You means a Member, and where the Member is under the age of 18, both the Member and the Member's parent/guardian.

(b) In these Conditions: any references: to the singular includes the plural and vice versa, to any gender includes all genders, to persons includes all bodies and associations both incorporated and unincorporated, to any legislation or regulation includes all amending and succeeding legislation and regulations, to the word "including" must be construed without limitation, to a "Clause" means a clause in these Conditions; and paragraph headings are for reference purposes only.

2. RULES OF MEMBERSHIP

- (a) These Conditions and any other terms and conditions of membership comprise a contract between You and Casey Leisure which is necessary and reasonable for promoting and conducting the Member Activities and administering Your membership.
- (b) You acknowledge this application for membership of Casey Leisure will be accepted upon notification to You by Casey Leisure and You acknowledge that You will be bound by and agree to comply with such rules, terms and conditions as may be imposed by Casey Leisure with respect to the conduct and management of the Member Activities, including but not limited to all relevant rules, regulations, policies and codes of conduct of Casey Leisure, as amended from time to time. You agree that You will follow any rules and/or directions set by Casey Leisure in connection with the Member Activities and understand that if You fail to comply with any such rules or directions You will not be permitted to participate or to continue to participate in the Member Activities and no refund will be given.
- (c) In consideration of Your membership application being accepted, You:
 - (i) must update Your contact details with Casey Leisure as soon as reasonably possible where they change; and
 - (ii) acknowledge and agree it is Your responsibility to cancel or suspend Your membership (in accordance with clauses 18 and 17 respectively) should You wish.

3. RISK WARNING

- (a) Participation in the recreational activities supplied by Casey Leisure is inherently dangerous and may involve risk. There are risks specifically associated with participation in the recreational activities and accidents can and often do happen which may result in personal injury, death or property damage. Prior to You undertaking any such recreational activity, You should ensure You are aware of all of the risks involved, including those risks associated with any health condition You may have.
- (b) By agreeing to these Conditions, You acknowledge, agree, and understand that participation in the recreational services provided by Casey Leisure may involve risk. You agree and undertake any such risk voluntarily and at Your own risk. You acknowledge that the assumption of risk and warning above constitutes a 'risk warning' in accordance with relevant legislation.

4. WAIVER

- (a) A supplier of recreational services or recreational activities can ask You to agree that statutory guarantees under the *Australian Consumer Law* (which is Schedule 2 to the *Competition and Consumer Act 2010* (Cth)) do not apply to You (or a person for whom or on whose behalf You are acquiring the services or activities).
- (b) By agreeing to these Conditions, You will be agreeing that Your rights (or the rights of a person for whom or on whose behalf You are acquiring the services) to sue the supplier in relation to recreational services or recreational activities undertaken because the services or recreational activities provided were not in accordance with the guarantees are excluded, restricted or modified as set out below.

For recreational services or recreational activities to which the Australian Consumer Law (Commonwealth) applies:

- (c) By agreeing to these Conditions, You agree that the liability of Casey Leisure in relation to recreational services (as that term is defined in the Competition and Consumer Act 2010 (Cth) and the Australian Consumer Law) for any:
 - (i) death;
 - (ii) physical or mental injury (including the aggravation, acceleration or recurrence of such an injury);
 - (iii) the contraction, aggravation or acceleration of a disease;
 - (iv) the coming into existence, the aggravation, acceleration or recurrence of any other condition, circumstance, occurrence, activity, form of behaviour, course of conduct or state of affairs:
 - (A) that is or may be harmful or disadvantageous to You or the community; or
 - (B) that may result in harm or disadvantage to You or the community, that may be suffered by You (or a person for whom or on whose behalf You are acquiring the services) resulting from the supply of recreational services or recreational activities,

is excluded and the application of any express or implied term that any services will be provided with due care and skill is hereby excluded.

For recreational services to which the Australian Consumer Law (Victoria) applies:

- (v) Warning under the Australian Consumer Law and Fair Trading Act 2012 (Vic): Under the Australian Consumer Law (Victoria), several statutory guarantees apply to the supply of certain goods and services. These guarantees mean that the supplier named in these Conditions, Casey Leisure, is required to ensure that the recreational services it supplies to You:
 - (A) are rendered with due care and skill;
 - (B) are reasonably fit for any purpose which you either expressly or by implication, make known to the supplier; and
 - (C) might reasonably be expected to achieve any result You have madeknown to the supplier.

Under section 22 of the Australian Consumer Law and Fair Trading Act 2012 (Vic), the supplier is entitled to ask You to agree that these conditions do not apply to You. If You agree to these Conditions, You will be agreeing that Your rights to sue the supplier under the Australian Consumer Law and Fair Trading Act 2012 (Vic) if You are killed or injured because the services were not in accordance with these guarantees, are excluded, restricted or modified in the way set out in these Conditions.

Note: The change to Your rights, as set out in these Conditions, does not apply if Your death or injury is due to gross negligence on the supplier's part. "*Gross negligence*" in relation to an act or omission, means doing the act or omitting to do an act with reckless disregard, with or without consciousness, for the consequences of the act or omission. See regulation 5 of the *Australian Consumer Law and Fair Trading Regulations 2012* (Vic) and section 22(3)(b) of the *Australian Consumer Law and Fair Trading Act 2012* (Vic).

Exclusion of rights under the Australian Consumer Law (Victoria): By agreeing to these Conditions, You agree that the liability of Casey Leisure for any death or personal injury (as defined in the Australian Consumer Law and Fair Trading Act 2012 (Vic)) that may be suffered by You (or a person from whom or on whose behalf You are acquiring the services) resulting from the supply of recreational services is excluded.

5. RELEASE AND INDEMNITY

In consideration of Casey Leisure accepting this application, to the extent permitted by law, You:

- (i) release and will release Casey Leisure from all Claims that You may have or may have had but for this release arising from or in connection with membership of Casey Leisure or participation in the Member Activities; and
- (ii) release and indemnify Casey Leisure against any Claim which may be made by You or on the Member's behalf for or in respect of or arising out of the Member's death whether caused by the negligence or breach of contract by Casey Leisure or in any other manner whatsoever; and
- (iii) indemnify and will keep indemnified Casey Leisure to the extent permitted by law in respect of any Claim by any person:
 - (A) arising as a result of or in connection with the Member's membership or your participation in any Member Activities; and
 - (B) against Casey Leisure in respect of any injury, loss or damage arising out of or in connection with the Member's failure to comply with Casey Leisure' rules and/or directions,

save that the above releases and indemnities shall not apply to the extent that the loss, damage or injury that is the subject of the Claim is caused or contributed to by the grossly negligent act or omission of Casey Leisure.

6. EXCLUSION OF LIABILITY

- (a) All express or implied guarantees, warranties, representations or other terms relating to these Conditions or their subject matter not expressly set out in these Conditions, are excluded from these Conditions to the maximum extent permitted by law.
- (b) Nothing in these Conditions excludes, restricts or modifies any right or remedy, or any guarantee, warranty or other term or condition, implied or imposed by any legislation that cannot be lawfully excluded or limited. This may include the *Australian Consumer Law*, which contains guarantees that protect the purchasers of goods and services in certain circumstances.
- (c) If any guarantee, warranty, term or condition is implied or imposed in relation to these Conditions under the *Australian Consumer Law* or any other applicable legislation and cannot be excluded (a Non-Excludable Provision), and Casey Leisure is able to limit Your remedy for a breach of the Non-Excludable Provision, the liability of Casey Leisure for breach of the Non-Excludable Provision is limited to one or more of the following at Casey Leisure' option:
 - (i) in the case of goods, the replacement of the goods or the supply of equivalent goods, the repair of the goods, the payment of the cost of replacing the goods or of acquiring equivalent goods, or the payment of the cost of having the goods repaired; or
 - (ii) in the case of services, the supplying of the services again, or the payment of the cost of having the services supplied again.
- (d) Subject to paragraphs (b) and (c) of this clause 6, the parties agree that the total liability of Casey Leisure to You for loss or damage of any kind whether arising in tort (including negligence), contract, under statute or otherwise is limited to the total amount of fees paid by You under these Conditions.

7. BAR TO PROCEEDINGS

- (a) You acknowledge that Casey Leisure may plead these Conditions as a bar to proceedings now or in the future commenced by or on behalf of You or on behalf of the Member or by any person claiming through You or the Member. Where You commence proceedings against Casey Leisure, You:
 - (i) will commence those proceedings in the courts of the jurisdiction in which any incident occurs;
 - (ii) waive any right to object to the exercise of such jurisdiction;

- (iii) will, where You seek to commence proceedings in another jurisdiction from where any incident occurs, consent (if required by Casey Leisure) to move those proceedings to the jurisdiction in which any incident occurs including consenting to any application made by Casey Leisure to remove the proceedings to the jurisdiction in which any incident occurs;
- (iv) will pay the costs of any application made by Casey Leisure under paragraph (iii) above and will consent to any application for security of costs made at any time by Casey Leisure; and
- (v) consent to paying Casey Leisure' legal defence costs of the proceedings (on a solicitor client basis) where Casey Leisure defends the proceedings.

8. INSURANCE

Insurance is in place that may provide limited cover to You or the Member whilst participating in the Member Activities. You understand that this insurance may not cover You for all injury, loss or damage sustained and You acknowledge that Casey Leisure does not make any representations about the suitability of any insurance. You also understand You can, in Your own interests and at Your own expense, seek and obtain personal insurances over and above any cover that may be provided by Casey Leisure.

9. FITNESS TO PARTICIPATE

You declare that You are medically and physically fit and able to participate in the Member Activities. You are not and must not be a danger to Yourself or to the health and safety of others.

10. MEDICAL TREATMENT

You consent to receiving any medical treatment that Casey Leisure reasonably considers necessary or desirable for You during participation in the Member Activities. You also agree to reimburse Casey Leisure for any costs or expenses incurred in providing You with medical treatment.

11. SAFETY

You understand and acknowledge the dangers associated with the consumption of alcohol or any mind-altering substance before or during the Member Activities, and You accept full responsibility for any injury, loss or damage associated with the consumption of alcohol or any other mind-altering substance.

12. RIGHT TO USE IMAGE

- (a) You acknowledge and consent to photographs and electronic images being taken of You during Your participation in any member Activities. You acknowledge and agree that such photographs and electronic images are owned by Casey Leisure and that Casey Leisure may use the photographs for promotional or other purposes without Your further consent being necessary. Further, You consent to Casey Leisure using Your name, image, likeness and performance in the Member Activities, at any time, by any form of media, to promote Casey Leisure.
- (b) You acknowledge and agree that any photography, video-recording or other filming undertaken by You during the Member Activities for commercial purposes is prohibited without the prior written consent of Casey Leisure and is subject to payment of such charges as may be set by Casey Leisure on a case by case basis.

13. PRIVACY

You understand that the personal information You provide in this application is collected, used and disclosed in accordance with the Privacy Policy of Casey Leisure (available at https://alignedleisure.com.au/privacy-policy/). You acknowledge that Your personal information may be used and disclosed by Casey Leisure for the purposes of conducting and administering Your membership, the Member Activities and other related activities across Australia, providing member services or promotional material, complying with legal obligations or otherwise in accordance with Casey Leisure' Privacy Policy. The holder of Your personal information may share that information with third parties strictly in accordance with and as detailed in the Privacy Policy however Your personal information will not generally be disclosed to anyone outside Australia. For the avoidance of doubt, your personal information will not be sold to other organisations and any marketing communications to you will be in accordance with the requirements under the Privacy Law. You understand that Casey Leisure' Privacy Policy contains information about how You may access and request correction of Your personal information held by Casey Leisure or make a complaint about the handling of Your personal information, and provides information about how a complaint will be dealt with by Casey Leisure. You acknowledge that Your application may be rejected if the information is not provided. If You do not wish to receive promotional material from Casey Leisure or its partners, sponsors, service providers and other third parties You must advise Casey Leisure in writing or via the opt-out procedures provided in the relevant communication.

14. NON-TRANSFERABLE

A right to participate in the Member Activities or to be a member of Casey Leisure (if granted) is non-transferable to other programs or to other people. Any attempt to transfer to another person without the knowledge of Casey Leisure may result in the cancellation of any rights granted by Casey Leisure without refund and You may not be permitted to participate in further Member Activities. You also accept that membership fees paid to Casey Leisure are non-refundable.

15. DIRECT DEBIT

- (a) I/We hereby authorize Payrix Australia Pty Ltd (ABN: 63 135 196 397) Direct Debit User ID 382220 to make periodic debits on behalf of Casey Leisure as indicated on the front of this Direct Debit Request (herein referred to as the Business)
- (b) I/We acknowledge that Payrix is acting as a Direct Debit Agent for the Business and that Payrix does not provide any goods or services and has no express or implied liability in regards to the goods and services provided by the Business or the terms and conditions of any agreement with the Business.
- (c) I/We acknowledge that Payrix and the Business will keep any information (including account details) contained in the Direct Debit Request confidential. Payrix and the Business will make reasonable efforts to keep any such information that we have about you secure and to ensure that any of our employees or agents who have access to information about you do not make any unauthorized use, modification, reproduction or disclosure of information. Payrix DDR Service Agreement Terms and Conditions can be found online on the Casey Leisure website terms and conditions page.
- (d) If paying by direct debit You agree to pay the instalment amount at the agreed payment frequency until Your membership is formally suspended or cancelled.
- (e) To help You understand Your rights and responsibilities when making repayments by direct debit, please see the below detail.
 - (i) We will give you at least fourteen (14) days' notice in writing of any changes to the terms of the direct debit.
 - (ii) We will keep all information relating to Your financial institution account confidential, except where required for the purposes of conducting

direct debits with Your financial institution or in connection with claims made on us relating to an alleged incorrect debit.

- (iii) Please ensure that Your nominated account can accept direct debits. If You are uncertain about this, please check with the financial institution where Your account is held.
- (iv) Please ensure that there are sufficient cleared funds available in the nominated account to meet each drawing on the due date.
 - (v) You must let us know as soon as possible if the nominated account is transferred or closed, or Your account details change.
 - (vi) You must give us seven (7) days' notice before the direct debit due date to change the account details from which the funds are being drawn from.
 - (vii) You need to give us fourteen (14) days' notice for cancelling Your membership.
 - (viii) If You consider that a direct debit repayment has been initiated incorrectly, or if You do not understand any aspect of the direct debit procedure, you should contact reception.
 - (ix) There may be a delay in processing the direct debit if there is a public holiday on the day of the debit.
 - (x) If we cannot withdraw the nominated amount from Your account (for example there is not enough money in Your account) it may dishonour the withdrawal and a dishonour fee of \$10.00 may apply.
 - (xi) Memberships will be cancelled if two consecutive debits are rejected. Memberships will be reactivated once the outstanding amounts have been settled.
 - (xii) In the case of an unsuccessful payment the debit may be added to your next fortnightly debit.
 - (xiii) Under normal circumstances no additional costs will occur above membership costs for direct debits.
 - (xiv) In the event that Casey Leisure ceases to operate its facilities, all financial records will be transferred to the City of Casey (owners of the facilities). The transfer will be made in line with up to date payment card industry compliance regulations.

16 PRICE INCREASES

Casey Leisure in partnership with City of Casey will adjust membership and service pricing at its absolute discretion only after providing one month's notice via an email to the email address that You have provided.

17. SUSPENSION

The first four (4) weeks of suspension are free each year. Extended membership suspensions are available for a minimum period of two (2) weeks and a maximum of eight (8) weeks per year at a cost of \$5 per week. Membership suspensions can be backdated to a maximum of 30 days if a medical certificate is provided.

A confirmation to be sent once the suspension has been applied. At the completion of the suspension period regular membership costs will resume.

18. CANCELLATION

- (a) You may terminate this Agreement before the expiry of the minimum term or payments if all the instalments and fees due up to the date of termination are paid, and in addition the cancellation fee of \$150 or the balance of remaining payments (whichever is the lesser). Once the cancellation fee or the balance of the remaining payments has been paid the Agreement ceases. After the expiry of the minimum term or payments, and after all instalments and fees due have been paid in full, should request to terminate at minimum term be chosen then this Contract shall automatically terminate. Should request to terminate at minimum term not be chosen, then the Contract shall continue indefinitely until such time as You request Casey Leisure, after the expiry of the minimum term, terminate the agreement. There will be a period of notice of 14 days unless otherwise specified by Casey Leisure between the date of request and the date of actual termination during which any payment due must still be paid in full.
- (b) Casey Leisure reserves the right to terminate Your membership in accordance with the following conditions:
 - (i) failure to comply with any of the criteria listed in the conditions of entry (as posted at any Casey Leisure facility) or the items listed in these Conditions;
 - (ii) action upon a complaint by either a facility member or an employee (or contractor) of Casey Leisure.

19. CONCESSION DISCOUNT

- (a) Holders of concession memberships are required to present current evidence of concession status within two weeks if requested. Failure to provide updated concession information will result in the membership automatically reverting to the appropriate non-discounted price.
- (b) The following cards will be recognised to qualify for a concession discount;
 - (i) Concession Cards (State and Federal);
 - (ii) Health Care Card;
 - (iii) Pension Card;
 - (iv) Seniors Card;

(v) Student Card.

20. ACCESS

- (a) All Members must scan their membership, wrist band or card upon entry to a Casey Leisure facility at every visit via the entry point or turnstiles. Scanning is compulsory.
- (b) Wrist band and card replacement costs are applicable if lost ordamaged.
- (c) Upon joining Casey Leisure a photo may be taken for security reasons relating to the safety of our Members. The photograph will not be used for any other purposes and will be stored securely on our database.
- (d) Entry to Casey Leisure may be refused as a result of unpaid or outstanding membership fees.
- (e) Members who allow their wrist band or card to be used by any other individual to access the facilities may have their membership cancelled

21. ENTITLEMENTS

Members have access to the following services within the Casey Leisure.

<u>Casey Full Access Membership – Casey ARC, Casey RACE, Endeavour Hills Leisure Centre, Doveton Pool in the Park (seasonal pool)</u>

All memberships are Full Access across all five Casey Leisure Facility sites and have access to:

- (i) Health Club and Group Fitness classes;
- (ii) Aquatic Facilities including waterslides and wave pool;
- (iii) Spa, Steam, Sauna Warm Water pool user must be 16+;
- (iv) Casual Shooting and Stadium access at Casey Stadium and Endeavour Hills Leisure Centre when not booked;
- (v) Access to 24/7 Health Club Facilities (18+)

Aquatic Membership - Casey ARC, Casey RACE, Doveton Pool in the Park (seasonal pool)

All Aquatic memberships have access to:

- (i) Aquatic Facilities including waterslides and wave pool;
- (ii) Spa, Steam, Sauna and Warm Water pool users must be 16+;
- (iii) Access to Doveton Pool in the Park

<u>Casey Full Access Teen Membership – Casey ARC, Casey RACE, Endeavour Hills Leisure Centre, Doveton Pool in the Park (seasonal pool)</u>

Casey Full Access Teen Membership minimum age is 12 years and can access the following:

- (i) Health Club; Prior to accessing Health Club Facilities, Teen members are required to undertake a Health Club planning session with a Parent or Guardian present in the session;
- (i) Group Fitness; High School members under the age of 16 must follow the below guidelines for Group Fitness classes
 - a. 12 and 13 Require Parent / Guardian in class
 - b. 14 and 15 No Boxing, Body Attack, Grit, Body Combat, Relentless classes
 - c. 16 and older can attend all group fitness classes
- (ii) Access during staffed Centre hours only:
- (iii) Aquatic Facilities. Over 16 years only for Spa, Steam and Sauna (Casey ARC and Casey RACE facilites);
- (iv) Stadium access when not booked;
- (v) Does not include access to 24/7 Health Club.

The Shed Memberships - The Shed Skatepark

All memberships are valid for the number of months purchased from membership start date and have access to;

- (ii) Unlimited entry during standard operating hours;
- (iii) All riders must complete an electronic waiver form prior to riding;
- (iv) Riders must wear a helmet, suitable clothing and closed toe footwear regardless of age or ability;

Casey Tigersharks Aquatic Membership - Casey ARC, Casey RACE, Doveton Pool in the Park (seasonal pool)

Casey Tigersharks Squad swimming memberships have access to Casey ARC, Casey RACE and Doveton Pool in the Park only during staffed hours.

- (i) Tigersharks Aquatic members must scan in at reception on each visit;
- (ii) Entry is for lap swimming only;
- (iii) Casey Leisure are 'Watch around Water' facilities. Children under 5 years must have an adult in the water within one arm's reach. Children between 5 and 10 years must have a parent or guardian over 16 years actively supervising at all times.
- (iv) Children under the age of 10 must be accompanied by a parent/guardian at least 16 years or over including during a swimming lesson.
- (v) Cancellations are in accordance with the procedures outlined in clause 18

<u>Casey Tigersharks Full Access Membership – Casey ARC, Casey RACE, Endeavour Hills Leisure, Doveton Pool in the Park (seasonal pool)</u>

Casey Tigersharks Full Access Membership minimum age is 12 years and can access the following:

- (i) Health Club; Prior to accessing Health Club Facilities, Teen members are required to undertake a Health Club planning session with a Parent or Guardian present in the session;
- (ii) Tigersharks members must scan in at reception on each visit;
- (iii) Spa, Steam, Sauna and Warm Water pool users must be 16+;
- (iv) Casey Leisure are 'Watch around Water' facilities. Children under 5 years must have an adult in the water within one arm's reach. Children between 5 and 10 years must have a parent or guardian over 16 years actively supervising at all times.
- (v) Children under the age of 10 must be accompanied by a parent/guardian at least 16 years or over including during a swimming lesson.
- (vi) Cancellations are in accordance with the procedures outlined in clause 18

Childcare - Casey ARC and Casey RACE

Childcare will incur additional costs, Enrolment forms must be completed and received by the Centre prior to child's first attendance, refer to www.caseyleisure.com.au/childcare for downloadable enrolment forms.

22. SWIMMING LESSONS - Casey ARC and Casey RACE

- (a) All participants must abide by the general terms and conditions of the swim school as notified to Members from time to time.
- (b) Participants will participate in swimming lessons utilising the Royal Life Saving Society's (RLSS) 'Swim and Survive Program'.
- (c) The following applies to all swim school members:
 - (i) Casey Leisure are 'Watch around Water' facilities. Children under 5 years must have an adult in the water within one arm's reach. Children between 5 and 10 years must have a parent or guardian over 16 years actively supervising at all times.
 - (ii) Children under the age of 10 must be accompanied by a parent/guardian at least 16 years or over including during a swimming lesson.
 - (iii) Certificates of participation and achievement will be issued by Casey Leisure, on behalf of RLSS, upon completion of a level. Participants will progress through the levels of the program as they attain the skills and confidence required to successfully complete the requirements of each certificate. The rate at which individual participants progress will be assessed on a case by case basis.
 - (iv) The program runs for 48 weeks of the year. Lessons are not conducted on public holidays. Make-up lessons are provided and are valid up to 90 days.
 - (v) Every effort will be made to adhere to the lesson times that have been provided to you. Management does, however, reserve the right to change or alter classes as necessary.
 - (vi) Swim school membership includes unlimited swimming with one supervisory adult, throughout the year.
 - (vii) Make-up lessons are available with a minimum 1 hours notice of student's lesson. Students have 8 make up lessons each year, they are valid for 90days and can only be used while swim lesson membership is current. There are no refunds for non-

- attendance of lessons. Make up lessons cannot be booked more than 7 days in advance and cannot be moved or rebooked. Make up lessons are subject to availability.
- (viii) Suspension of swim school membership is offered during the December/January school holidays or membership can be maintained for swimming access. Medical suspensions are available for a minimum of two consecutive lessons and for a maximum of eight missed lessons. Medical certificates are required and cannot be backdated more than 30days.
- (ix) Changing of swim levels occurs from 'infant and pre-school' to 'school' level. There are increased costs, and these will adjust automatically once the swim lesson booking is changed to the next level.
- (x) Children up to the age of 24 months must wear bathers with elastic waist and leg bands or aqua nappies. Disposable or cloth nappies are not permitted.
- (xi) Direct debit will occur across twenty-six (26) fortnightly payments and adhere to the same terms and conditions as outlined in clause 15 above. Debits continue over school holiday periods.
- (xii) Families with multiple children enrolled in Swimming Lessons and/or Gymnastics may be eligible for a discount on their second enrolment. Cancellation of enrolment will result in the membership automatically reverting to the appropriate non-discounted price.
- (xiii) Swim school membership will be cancelled if two consecutive debits are rejected. Swim school membership will be reactivated once the outstanding amounts have been settled.
- (xiv) Cancellations are in accordance with the procedures outlined

in clause 18

23. GYMNASTICS - CASEY STADIUM AND ENDEAVOUR HILLS LEISURE CENTRE

- (a) The following applies to all Gymnastics members:
 - (i) The program runs for 46 weeks of the year, classes do not run during the first week of Victorian school term holidays and over the December/January school holidays no classes run for 4 weeks. Lessons are not conducted on public holidays. Make up lessons are provided and are valid up to 90 days.
 - (ii) Every effort will be made to adhere to the lesson times that have been provided to you. Management does however reserve the right to change or alter classes as necessary.
 - (iii) For safety, if the temperature inside of the gymnastics hall is equal or greater than 36 degrees with no cool change forecast classes may be cancelled.
 - (iv) An annual registration fee is to be paid upon enrolment for each child and on the first direct debit of the year. The registration fee includes Aligned Leisure administration fee and registration with Gymnastics Victoria and Gymnastics Australia.
 - (v) Make-up classes are available with a minimum 1 hours notice of student's classes. Students have 8 make up lessons each year, they are valid to be used up to 90 days and there are no refunds for non-attendance of classes. Make up classes can not be booked more than 7 days in advance and can not be rebooked. Make up lessons are subject to availability.
 - (vi) Medical suspensions are available for a minimum of two consecutive lessons and for a maximum of eight missed lessons. Medical certificates are required and cannot be backdated more than 30 days.
 - (vii) Children under 10 must be accompanied by a parent/guardian at all times, including during a class. A designated viewing area for parent/guardian is available.
 - (viii) Families with multiple children enrolled in Swimming Lessons and/or Gymnastics may be eligible for a discount on their second enrolment. Cancellation of enrolment will result in the membership automatically reverting to the appropriate non-discounted price.
 - (ix) Direct debit will occur across Victorian school terms in fortnightly payments and adhere to the same terms and conditions as outlined in clause 15 above.
 - (x) Cancellations are in accordance with the procedures outlined in clause 18.

24. CHANGES TO OPERATION

- (a) Casey Leisure may be required from time to time to update the operation of the facilities under its control, including but not limited to:
 - (i) operating hours;
 - (ii) availability of specific facilities or services withinfacilities;
 - (iii) closure of part of the facility or premises, or of specific equipment, for maintenance; and
 - (iv) changing conditions of entry to the facility.

(b) Where a change outlined above occurs, Casey Leisure will use its best endeavours to provide reasonable notice to Members, by way of (including but not limited to) its website, email, SMS and noticeboards.

25. GENERAL

- (a) In the event that Casey Leisure ceases to operate, Your membership and any payment arrangements will transfer to the City of Casey or its nominated operator.
- (b) These Conditions comprise the entire agreement between the parties in relation to its subject matter and supersede and replace any previous agreement or arrangement between the parties in relation to its subject matter.
- (c) Casey Leisure reserves the right in its sole discretion to vary these Conditions by providing You with one month's advance notice of any variation. The notice may be provided by any reasonable communication method, including but not limited to Casey Leisure' website, social media channels, email, SMS or signage.
- (d) Any provision of this Agreement which is void or unenforceable may be severed without affecting the enforceability of other provisions.
- (e) These Conditions are governed by the laws of Victoria and the parties submit to the exclusive jurisdiction of the courts of Victoria.
- (f) You warrant that all information provided to Casey Leisure is true and correct.
